CWA National Convention

The 72nd CWA National Convention and Legislative Political Conference was held in Washington D.C. from July 25-29. The convention was well-attended with over 1,200 delegates and hundreds of alternates and supporters. As President Larry Cohen said, there are no "guests" here today, just CWA, family, friends and allies. He added that "It's not hopeless, just hard and we've done hard before" and emphasized the importance of signing up RMC (retirees) members to join our movement to fight for health care, social security, and Medicare; and to stay active in CWA. Convention delegates again voted to move CWA forward and adopted several changes that will support building our union. That action continues the work of the Ready for the Future campaign that began in 2005.

Convention highlights: Biennial conventions that take effect in 2011; Merger of Districts 2 & 13; Merger of Communications and Technologies and Telecommunications Sectors; Vote on the Executive Board for the Canadian Director; Women's Committee name change; Civil Rights Equity Committee name change.

Final note, there was an appeal filed by local 9404 asking District 9 to arbitrate grievances against AT&T PIP policy against one of its member. District 9 agreed to arbitrate the grievances on PIP before it went to the convention floor. Congrats to Prez Carol Whichard! Next CWA National Convention will be held in Las Vegas in August of 2011.

President's Message

The following question regarding The Service Technicians that were assigned into the Premises Technician title is; will those S.T.'s retain the Appendix A benefits if they subsequently move? The answer is yes.

The Technicians "assigned" into the Premises Tech title will only lose the Appendix A benefits if they voluntarily transfer into another TITLE. You can find the language in The Collective Bargaining Agreement Appendix E 1.01 D, the last paragraph page 189. Company labor has supposedly notified 1St line management, so if there is confusion please contact the Local.

Several members from our local have advised that there seems to be a problem with the 401K benefits for those members that were moved into the Premise Technician Title from the Service Technician Title. The District contacted Labor and found that the Service Technicians that were moved into the Premise Technician position were coded incorrectly and that it caused those members to be shown as under the "new hire" benefits for the 401K. Again, this is being corrected and the District will let the local know when the corrections are completed.

Let the Local know when and how much overtime you are being offered if that overtime is for completion of any service technician work. If there is a surplus then there should be little to no overtime. Apparently the company has been fined for not meeting service standards.

All members should call the local or request a steward before meeting with company management. Remember company managers' documentation can lead to your suspension or termination.

This is the 90th anniversary of the 19th Amendment of the Constitution of the United States giving Women the right to vote. Celebrate that anniversary in your local community on August 26, 2010.
