SMART Meter Coming Soon

For many of the outside plant technician, PG&E is starting to place smart meters into many of the homes in the Bay Area. We need to know what are the health and safety risks for our members being exposed to the RF. A recommendation to the CPUC is to let consumer opt out for the POTS line connection to the Smart Meter.

I was able to speak before the CPUC on this matter and asked that they consider our member's health and safety risk with the Smart Meter RF exposure. EMF Safety Network said "Smart Meters are radio transmitters, sending radiofrequency microwave radiation (RF) signals from both electric and gas meters. The electric meter has two transmitters. One RF signal is sent directly into your home (or business), and the other to a neighborhood data collector, which could be located on a lamppost, telephone pole, building or a home. Homes will also be used as repeaters for neighborhood RF signals."

The next hearing in San Francisco is on Thursday, March 10, same day as the reviewing of the changes for basic telephone service.

CWA District Nine California Legislative Conference
